**Sub: Request for declaration of additional result from waiting list against vacancy for DRJAO 2017 Quota reg.....**

In reference to aforesaid context vide letter under reference, it has been requested to declare result for 168 vacancies of 23 circles.

In general for all cadres while appointing a candidate from the declared merit list all pre-appointment formalities/training etc. are completed. In case any candidate fails to complete the process then concerned circle communicates candidate indicating the incomplete process and finally ascertains the vacancy status either on the basis of response or no response from the candidate. Thus such until & unless entire aspect of pre-appointment formalities etc. are ascertained & ensured without any prejudice, it may not be judicious/effective to decide/declare a place as vacant else any oblivious approach would lead to legal contradiction in matter from deserving candidates.

In view of above, a comprehensive list of left out vacancies of all circles, indicating category along with name of candidate who is not going to be appointed in BSNL (from originally declared merit list) without any pre-judice, may be please be sent after taking in to account all considerations of pre-appointment formalities to get rid of legal contradiction, for taking further necessary action accordingly.
