Subject: Payment of leave encashment in respect of VRS-2019 optees whose Vigilance clearance is withheld.

Sir,

I am directed to refer to the notification of BSNL Voluntary Retirement Scheme-2019 issued vide letter No. 1-15/2019-PAT(BSNL) dated 04.11.2019 and to inform that this office has received some references with regard to withholding of amount of encashment of EL / HPL in respect of VRS-2019 optees whose Vigilance clearance is withheld.

- 2. The issue of payment of leave encashment, in cases where vigilance clearance is withheld, has been examined in consultation with EF branch of BSNL Corporate Office vis-à-vis the relevant provisions of the BSNL VRS-2019 and Rule 39(3) of CCS(Leave) rules. It is clarified that the competent authority for sanctioning the amount of encashment of EL / HPL is required to examine each case individually to find out whether withheld Ex-gratia and Gratuity will be insufficient for adjustment of the amount recoverable from the retired employee on conclusion of the disciplinary proceedings pending against him and thereby requiring adjustment of remaining amount from leave encashment. In other words, only in such cases where the amount recoverable exceeds the amount of gratuity and ex-gratia withheld, withholding of leave encashment will be necessitated.
- 3. The authorities competent to sanction encashment of EL/HPL in respect of retired employees may, accordingly, review all cases where leave encashment has not been released on account of withholding of vigilance clearance in respect of retired employee. Such authority may also consult the concerned disciplinary authority, if need be, for ascertaining the amount likely to become recoverable from the retired employee on conclusion of disciplinary proceedings.

Subject: Immediate sending of pending pension cases to CCAs for generation of PPOs in respect of the employees retired voluntarily under the BSNL VRS-2019.

Sir,

I am directed to refer to this office letter of even no. dated 23.06.2020 on the above cited subject and to forward herewith the latest status (as on 19.06.2020) of the pension cases sent to CCA offices for settlement of pension in respect of retirees under BSNL VRS- 2019. It is observed that even after regular reminders from this office, the sending of pesion cases to CCAs has not improved in some circles.

- Further, it has been noticed that the pension papers of the VC withheld cases are not being sent to the CCA offices. In this regard, it is informed that such retirees will be considered for payment of provision pension by the respective CCAs. Therefore, sending of such pension cases may be imdiately undertaken and their early settlement may be ensured by close coordination with CCA offices.
- Another issue which has come to the knowledge of this office that in respect of VC withheld cases payment of Leave encashment has not been initiated by the circles. Clear instructions have been issued by this office as per letter No. BSNLCO-EB-I/11(20)/ 5/2020-ESTAB dated 06.05.2020 (available on BSNL Intranet). In this regard, it is again requested that the details of EL encashment finalized in such cases may be immediately updated in the ERP / SAP portal.

This may be treated as most urgent.
