2. However, before issue of Presidential order, it may be ensured that no vigilance case/disciplinary case pending/contemplated against the officials. It may also be checked that regularisation of the above-mentioned official has been done in pursuance of letter No. 269-94/98-STN.II dated 29.09.2000. The POs of the above-mentioned officials may be issued in their substantive grade as on 30.09.2000 after due verification of their records. In other words, the PO should be issued on same terms and conditions as were applicable to similarly placed persons, after due verification of service rendered.
