Subject: Limited Internal Competitive Examination for promotion to the grade of JTO(T) under 50% quota for vacancies up-to 31.3.2018-reg.

The undersigned is directed to convey the approval of the Competent Authority for holding of LICE (Limited Internal Competitive Examination) for promotion to the post of JTO(T) under 50% internal quota for the vacancy year 2016-17 and 2017-18. The LICE for JTO for the vacancy year 2016-17 and 2017-18 shall be conducted as per provisions laid in the Recruitment Rules of JTO(T) 2014 issued vide this office letter no.5-32/2013-Estt-IV dated 14.10.2015. Further necessary information for conducting LICE upto vacancy 31.03.2018 are mentioned below:

- 1. The LICE will be held as per the scheme and sullabus circulated vide this office letter of even No.dated 20.10.2009 and modified vide letter of even No.dated 1.11.2011.
- 2. All the recruiting circles may be directed to calculate the year-wise vacancies (OC/SC/ST) under 50% quota (including Non-recruiting circles and Maintenance Region circles) according to the instruction of DoP&T OM.No.AB14017/2/1997-Estt.(RR)-Pt.dated 19.1.2007, endorsed vide BSNL CO.Memo No.250-4/2007-Pers-III dated 7.8.2007 and letter no.5-32/2013 dated 15.10.2015 issued by this office. The unfilled vacancies in any vacancy year will be carried forward to the subsequent year as per extant rules.
- 3. The eligibility for appearing in the JTO(T) LICE shall be as per JTO RRs of 2014 as endorsed vide this office letter no.5-32/2013-Estt. Dated 14.10.2015

- 4. Crucial date for determing the qualifying service (i.e.5 years) will be 1<sup>st</sup> july of the respective vacancy year against which the candidature of the official is being considered.
- 5. Cut off date for reckoning age for 50% quota candidates will be 1st july of the vacancy year (i.e.they must be below the age of 55 year as on 1st july of the vacancy year).
- 6. Examination will be conducted for 50% quota for all the vacancy years upto 31.03.2018, however, eligibility will be determined as on 1st july of the respective vacancy year and result will be declared accordingly yearwise for each quota separately.
- 7. Recruitment year for all the candidates will be the year in which notification for the examination is issued.
- 8. Since it is competitive exam, results shall be declared upto the notified vacancies for the particular year i.e 2016-17 and 2017-18 only.
