| Plan Name | No. of APs | Bandwidth | Annual Plan Charges (in Rs.) |
|-----------|------------|--------------------|---------------------------------|
| PWP 502H | 50 | 200 Mbps | 28,50,000/- |
| PWP 1H5H | 100 | 500 Mbps | 52,00,000/- |
| PWP 2H1K | 200 | 1 Gbps (1000 Mbps) | 92,00,000/- |

- 4. Any discounting power for above plans shall be decided by BSNL Corporate office with the approval of Director (CFA).
- 5. Cost of Additional APs & incremental bandwidth shall be as per existing circulars and subsequent clarifications issued.
- 6. All other terms & Conditions including revenue share shall be as per the PWP open policy dated 24-06-2021.
- 7. The Circles should ensure to comply with all regulatory requirements.
- 8. All the above mentioned charges are excluding GST.
- 9. These instructions shall be effective from the date of issue of this circular.
