Sub:- Settlement of Claims recoverable from DoT on account of providing Mobile Telephone Service Connections to DoT Officers/Officials Working/Retirees up to the year 2023-24.

Ref:- 1. This office letters of even no Dt. 18/01/2023, 05/04/2023, 05/07/2023, 27/09/2023, 11/12/2023, 22/04/2024 and 28/05/2024 followed by Email Dt 16/05/2023, 31/05/2023 and 17.01.2024.
2. Letter No. BSNLCO-COMN/11(26)/4/2020-CS_CSC n RN CFA dt 06/05/2024 and 24/05/2024 issued by PGM (CS-CSC & RN) CO BSNL.

Kindly refer to the letters, reminders & emails mentioned under references above vide which instructions were issued to coordinate with the concerned CCA offices for DoT claims verification and reconciliation for the Service Telephone Facilities (Including Mobile) provided to DoT officers/officials and to get the claims settled as per the instructions issued by DoT vide it's circular No. 32-2/2020-PHP Dt 19/08/2021 (copy of letter attached).

As per the details provided by Circles, claims for Rs. 12.55 crore up to Dec., 2023 have been raised for the GSM service connections by concerned circles to DoT officer/officials (Annexure -A). However as per report received, nothing has been recovered by any of the circle out of the claims/invoices of Rs. 12.55 crore, which clearly indicates that Circles are not making desired efforts for claiming, reconciling & receiving the payments from concerned offices/units of DoT.

Multiple reminders have been issued by this office for verifying, pursuing & realizing the BSNL dues wherein it was also conveyed that "the claim for the GSM Postpaid facilities provided to DoT officers/officials from 01.10.2000 onwards will be settled by the Circles with concerned DoT offices/CCA units.

DOT has requested to CGCA New Delhi, Vide it's letter dated 08.04.2024, to direct all the concerned CCA offices to complete the verification process at the earliest. DoT has also conveyed to provide all the requisite information to respective Circle Level Committee formed by CCAs for verifying the details of service Telephone connections to DoT. This includes mobile service connections also.

In view of above, Circle Heads are requested to kindly look into the matter personally and to direct nodal officers & concerned PGM/GM-CM of Circle Office to continuously pursue for GSM claims also with concerned CCA offices for expediting the verification of the details which might have submitted to CCAs by the Circles and also to submit the balance details, if any, for early release of the payment by DoT.

Circles are requested to arrange to provide GSM claims verification status mentioning therein the total claimed amount, verified by CCA/DoT, amount realized and amount balance etc. A quarterly progress report in this regard may kindly be submitted to this office through e-mail id to dgmrmmcm@gmail.com latest by 15th of the following month for further review by the higher authority.
