**Subject:- Limited Internal Competitive Examinations (LICE) for promotion of Group 'C' employees to the grade of Junior Telecom Officer (Telecom) [JTO(T)] in BSNL under 50% internal quota for vacancy year 2023 held on 08.09.2024 and addendum to Merit list issued on 19.11.2024 thereof reg..**

**2.** However, with reference to Recruitment Branch letter dated 19.11.2024, Chhattisgarh, Odisha & Karnataka circles have noticed discrepancies in the declared merit list & reported through email on bsnlrectt@bsnl.co.in.

**3.** It thus appears that during e-verification, the aspect of Parent circle was not taken care of cautiously, due to which the candidate had to be removed from the merit list. The higher authorities have viewed the matter seriously and desired to apprise all concerned to be meticulous during e-Verification of eligibility.

**4.** Accurate and timely updating of duly verified data in SAP from service book as well as taking consideration of all the relevant parameters required for e-verification, ensures economy of time & resources at all level and all concerned in the process. Because of the discrepancies due to improper attention during e-verification leads to delay in taking up further LICEs and thereby aspiring candidates gets deprived from appearing in subsequent LICEs in optimum time.

**5.** Accordingly, the discrepancies in terms of Parent circles (updated later on by the circles) reported have been verified at this end on the basis of information provided by the circles as well as update in SAP-ERP w.r.t change of parent circle under Rule-8 and resignation from service.

**6.** The detailed amendment in merit list is placed as below: Accordingly, following list of Addendum/Deletion is placed in the tabulations below. Following candidates are deleted from the said Merit list against the Circles mentioned thereof as due to inadvertent wrong/improper/inputs at different levels viz. Parent circle/ Recruiting circle/Transfer under Rule-8/Rule-9 etc. **(Table 1). Table:- 2** mentions the additions in merit list due to revisions of Table 1.
