**Subject:-** JTO (Telecom) Promotion issue of LICE VY 2023(Telangana Circle) – Case of Shri Thadaka Mahesh, JE Per No.-60210232 O/o SDE (CM & CFA) Bhupalpally sub-division, Warangal BA, Telangana Circle.

We wish to draw your personal kind attention towards the subject and enclose herewith a representation from Shri Thadaka Mahesh, JE of Telangana Circle addressed to the G.S. of our union and the representation alongwith the relevant document in support of his claim to the Chief General Manager Telecom BSNL Telangana Circle.


The case of official in brief is as follow:-

- (1) That the said official said official Shri Thadaka Mahesh, JE was appeared in JTO LIC for the VY of 2023 and the LICE was conducted on 08-09-2024.
- (2) He appeared for the Limited Internal Competitive Examination (LICE) for promotion to JTO (Telecom) under 50% internal quota for vacancy year 2023, conducted on 08-09-2024, and secured 125.25 marks.
- (3) In the Telangana circle merit list, three posts were notified under the General (OC) category. As per the published result, the third post was allotted to Shri Ravi Nayak B (Roll No.-50001696) under the OC-PwBD Category.
- (4) Subsequently, the Corporate office letter dt-16-04-2025, communicated through Telangana Circle letter dated 17-04-2025, confirmed that Shri Ravi Nayak B had already been selected under the PwBD category for LICE VY-2021.
- (5) Since his candidature has already been considered for VY-2021, the post allotted to him in VY-2023 has effectively become vacant. It is also pertinent to mention that no other PwBD candidate appeared for the VY -2023 examination in Telangana Circle.
- (6) Therefore, the third post remains unfilled, and as he is the next eligible candidate in the General category merit list, he submitted a formal representation on 30-04-2025, requesting the release of a revised merit list and allotment of the vacant post.

Under the circumstances and facts mentioned above the claim of Shri Thadaka Mahesh JE is genuine and justified. Hence we implore upon you to kindly look into the matter personally and review the case so that the qualified candidate may get justice.
